





## I. EXPLANATORY NOTE

### 1.1. Characteristics of the discipline

The study of the historical and religious heritage of the peoples of Russia is currently very promising. The relevance of the program is due to the need to build intercultural and interfaith dialogue using a comprehensive analysis of internal and external processes occurring in Russian society and associated with the formation of state-confessional policy.

The concept of "culture" has been firmly connected with ideas about human activity since ancient times. Each culture is a system of meanings with its own essence and internal logic. But it is not only a system of knowledge, it is also a system of familiarization with other cultures, worlds, and their interpenetration. Culturology is the implementation of a dialogue of cultures. Based on well-founded theories, culturology synthesizes materials from individual sciences about culture, which gives it the opportunity to comprehensively study the cultures of different eras and peoples.

### 1.2. Purpose and objectives of the discipline.

#### **The purpose of teaching the discipline:**

**The goal is** to familiarize students with the main patterns and trends in the development of world cultures and religions, the role of Russia in the genesis of world culture; to form an understanding of universal human values aimed at the spiritual enrichment of youth.

#### **Learning objectives of the discipline:**

- to introduce students to the main content of the material and spiritual culture of the peoples of the world, to help them navigate the world of cultural symbols and trends in art, literature, music, etc.;
- to promote the formation of cultural orientations and attitudes of students' personalities, and the development of their spiritual potential;
- to form a humanitarian cultural environment at the university, using an interdisciplinary approach in teaching students historical, philosophical, cultural, political and economic disciplines;
- to teach students the necessary minimum of theoretical knowledge about culture as a system, to update it using a historical approach in the analysis of world cultures and religions at various stages of society's development.

### 1.3. The place of the discipline in the structure of the main professional educational program of higher education.

In accordance with the Federal State Educational Standard of Higher Education - specialist in specialty 31.05.01 General Medicine (2020), the discipline "History of Culture and Religions of Russia" refers to the disciplines of the basic part, Block 1. An optional course, elective disciplines are taught in the 1st year, in the 2nd semester. The total workload is 1 credit (36 hours). Of these, 24 classroom hours, 12 hours are allocated for independent work of students. Form of control: credit in the 2nd semester.

Students are taught on the basis of continuity of knowledge and skills acquired in the school social studies course.

The basic knowledge necessary for studying the discipline is formed in the cycle of humanitarian and social disciplines.

Mastering the discipline "History of Culture and Religions of Russia" precedes the study of: philosophy; bioethics, jurisprudence.

Requirements for input knowledge, competencies and skills for studying the discipline: knowledge of a comprehensive school graduate in social studies.

### 1.4 Requirements for students

To study the discipline "History of Culture and Religions of Russia", a student must have the necessary knowledge, skills and abilities developed in institutions of secondary (complete) general education:

Social science
<b>Knowledge :</b> the basic laws of social development, characteristics of society as a whole, the place of man in society, the main categories of the spiritual sphere, social relations, experience in the field of national and universal culture, the main stages of the development of world history and culture.
<b>Skills:</b> generalize, analyze information, set goals and choose ways to achieve them, form and express your thoughts. Characterize the main cultural and historical phenomena, highlighting their essential features, patterns of development.
<b>Skills:</b> possess skills in working with various sources of information: books, textbooks, reference books, atlases, maps, guides, encyclopedias, catalogues, dictionaries, Internet resources.

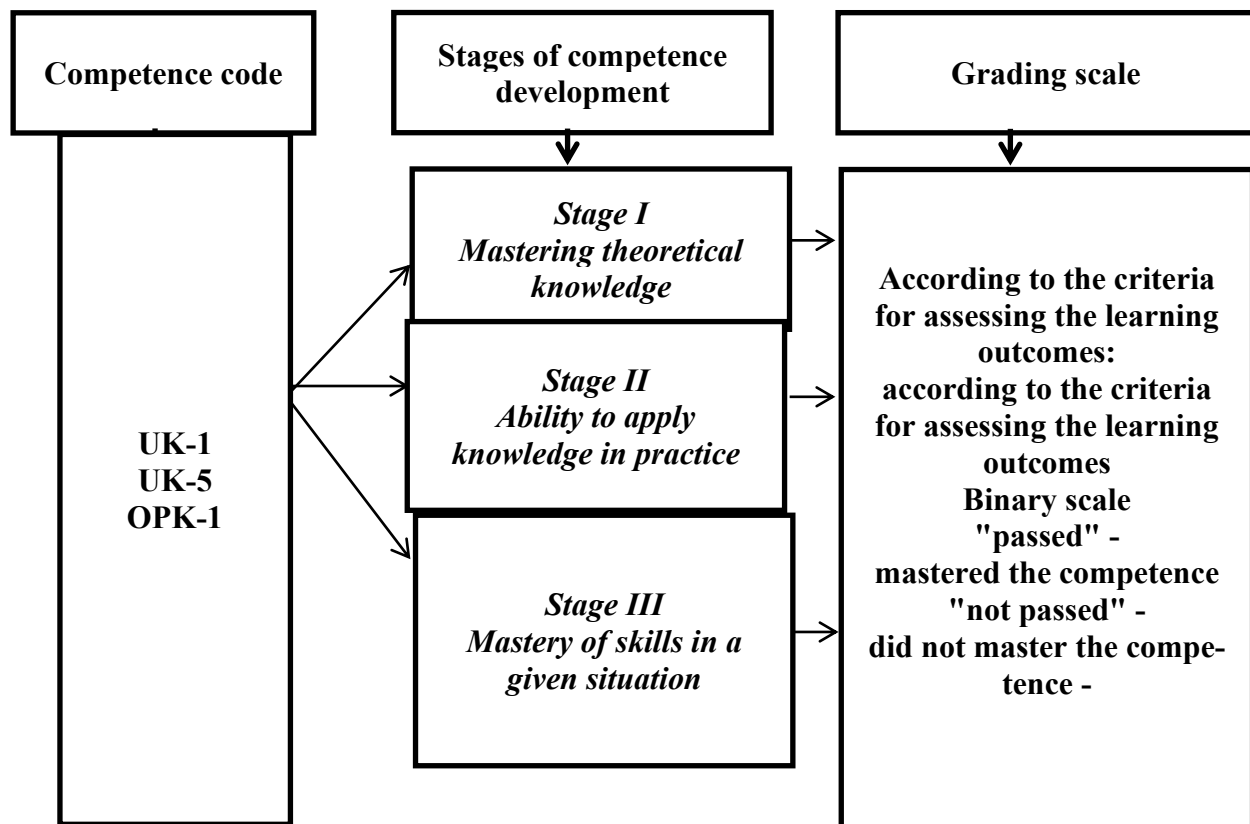

## 2.5 Criteria for assessing students' knowledge

The assessment of learning outcomes is carried out in accordance with the “Regulations on the system for assessing the learning outcomes of students of the Federal State Budgetary Educational Institution of Higher Education Amur State Medical Academy of the Ministry of Health of Russia.

The basis for determining the level of knowledge, skills, and abilities are the assessment criteria - completeness and correctness:

- correct, precise answer;
- correct but incomplete or imprecise answer
- incorrect answer; no answer.

When assigning marks, the classification of errors and their quality are taken into account:

- gross errors;
- similar errors;
- minor errors; shortcomings.

The success of students in mastering the topics of the discipline "Physics, Mathematics" is determined by the quality of mastering knowledge, skills and practical abilities; the assessment is given on a five-point scale: "5" - excellent, "4" - good, "3" - satisfactory, "2" - unsatisfactory.

### Incoming inspection

Conducted during the first lesson, includes: solving problems and exercises; testing in the Moodle system <https://educ-amursma.ru/local/crw/course.php?id=879>

The test control includes 100 questions on the social science course studied in secondary (complete) general education institutions.

### Current control

Current control includes initial and final control of knowledge.

Initial control is carried out by the teacher at the beginning of each lesson in the form of a frontal survey, solving problems and exercises.

Final control – includes an oral conversation with the teacher, solving problems using options, testing in the Moodle system <https://educ-amursma.ru/local/crw/course.php?id=879>.

The final grade during the current knowledge assessment is given on the day of the lesson, as the arithmetic mean result for all types of activities provided for in the given lesson of the discipline's work program.

#### Criteria for assessing the oral response

- **“5” (excellent)** – the student demonstrates deep and complete knowledge of the educational material, does not allow inaccuracies or distortions of facts when presenting, presents the material in a logical sequence, is well oriented in the presented material, and can provide justification for the judgments expressed.
- **“4” (good)** - the student has mastered the educational material in full, is well oriented in the educational material, presents the material in a logical sequence, but makes inaccuracies when answering.
- **“3” (satisfactory)** – the student has mastered the basic principles of the topic of the practical lesson, but when presenting the educational material, he/she makes inaccuracies, presents it incompletely and inconsistently, requires leading questions from the teacher to present it, and has difficulty substantiating the judgments made.
- **“2” (unsatisfactory)** – the student has fragmented and unsystematic knowledge of the educational material, is unable to distinguish between the main and the secondary, makes mistakes in defining basic concepts, distorts their meaning, and cannot independently present the material.

#### Assessment criteria for the practical part

- **“5” (excellent)** – the student has fully mastered the practical skills and abilities provided for by the course work program.
- **“4” (good)** - the student has fully mastered the practical skills and abilities provided by the work program of discipline, but allows for some inaccuracies.
- **“3” (satisfactory)** – the student has only some practical skills and abilities.
- **“2” (unsatisfactory)** - the student demonstrates the implementation of practical skills with gross errors.

#### Criteria for assessing independent extracurricular work:

- the level of student mastery of the educational material;
- the completeness and depth of general educational concepts, knowledge and skills on the topic being studied, to which this independent work relates;
- development of universal and general professional competencies (ability to apply theoretical knowledge in practice).
- the problems were solved correctly, the exercises were completed, and the test assignments were answered accurately – “passed”.
- Problems were not solved correctly, exercises were not completed correctly, test assignments were not answered accurately – “failed”.

#### Essay evaluation criteria:

- **“5” (excellent)** – awarded to a student if he has prepared a complete, detailed, and formatted according to requirements, abstract on the chosen topic, presented his work in the form of a report with a computer presentation, and answered questions on the topic of the report;

- **“4” (good)** – awarded to a student for a complete, detailed essay that is formatted according to requirements, but poorly presented;
- **“3” (satisfactory)** – the abstract does not contain information on the issue being studied in full, is formatted with errors, and is poorly presented;
- **“2” (unsatisfactory)** – given to a student if the abstract is not written, or is written with gross errors, the report and computer presentation are not prepared, or their content does not correspond to the topic of the abstract.

#### **Working off disciplinary debts.**

1. If a student misses a class for a valid reason, he/she has the right to make it up and receive the maximum grade provided for by the course work program for that class. A valid reason must be documented.
2. If a student misses a class for an unjustified reason or receives a "2" mark for all activities in the class, he/she is required to make it up. In this case, the mark received for all activities is multiplied by 0.8.
3. If a student is excused from a class at the request of the dean's office (participation in sports, cultural and other events), then he is given a grade of "5" for this class, provided that he submits a report on the completion of mandatory extracurricular independent work on the topic of the missed class.

#### **Criteria for assessing midterm assessment.**

Midterm assessment (credit) is intended to assess the degree of achievement of planned learning outcomes upon completion of the study of a discipline and allows for an assessment of the level and quality of its mastery by students.

The students' success in mastering the discipline is assessed on a 5-point scale: “5” - excellent, “4” - good, “3” - satisfactory, “2” - unsatisfactory.

**"Excellent"** - for the depth and completeness of mastery of the content of the educational material, in which the student easily navigates, for the ability to connect theoretical questions with practical ones, express and justify their judgments, correctly and logically present the answer; when testing, allows up to 10% of erroneous answers. Practical skills and abilities provided for by the working program of the discipline are fully mastered.

**"Good"** - the student has fully mastered the educational material, is oriented in it, correctly states the answer, but the content and form have some inaccuracies; during testing allows up to 20% of erroneous answers. Completely practical skills and abilities provided by the working program of the discipline, but allows some inaccuracies

**"Satisfactory"** - the student has mastered the knowledge and understanding of the main provisions of the educational material, but presents it incompletely, inconsistently, does not know how to express and justify his/her judgments; during testing, allows up to 30% of erroneous answers. Has only some practical skills and abilities.

**"Unsatisfactory"** - the student has fragmented and unsystematic knowledge of the educational material, is unable to distinguish between the main and secondary, makes mistakes in defining concepts, distorts their meaning, presents the material in a disorderly and uncertain manner, and makes more than 30% of erroneous answers during testing. Performs practical skills and abilities with gross errors.

A student may qualify for an "excellent" grade automatically if he/she has won a prize in disciplinary or interdisciplinary Olympiads (university, regional ) and has an average grade for the current academic performance of at least 4.8 points . A student may refuse an "automatic" grade and take the test together with the group on a general basis.

#### **Interim assessment is carried out through a system of passing a test in 3 stages:**

1. Testing in the system " Moodle " <https://educ-amursma.ru/local/crw/course.php?id=879>.
2. Completion of the practical part of the discipline in full: involves attending all practical classes, performing experiments with the execution of a protocol. Based on the assessments of the current control of knowledge, skills, and abilities in practical classes, the average score of current academic performance is calculated, which is recorded in the educational (electronic)

journal. The average score of the current knowledge control is taken into account during the midterm assessment.

3. Delivery of practical skills (control of the level of development of competencies). Includes 10 options, containing 10 questions of a practical nature.

#### 2.6 Independent work of students: in-class and out-of-class.

The organization of independent classroom work of students is carried out with the help of methodological instructions for students, which contain educational goals, a list of the main theoretical questions for study, a list of practical work and the methodology for conducting it, instructions for the presentation of the results obtained, their discussion and conclusions, assignments for self-control with standard answers, a list of recommended literature.

From 1/4 to 1/2 of the practical lesson time is allocated for independent work of students: conducting research, solving problems, recording results, discussing them, formulating conclusions, completing individual assignments. The preparatory stage, or the formation of an approximate basis for actions, begins for students outside of class time when preparing for the practical lesson, and ends in class.

All subsequent stages are carried out in class. The stage of materialized actions (solving problems using an algorithm or without an algorithm, with an unknown answer in advance) is carried out independently. The teacher, if necessary, provides consultation, provides assistance and simultaneously monitors the quality of students' knowledge and their ability to apply existing knowledge to solve assigned problems.

## 2.7 Research (project) work

Students' research (project) work (SRW) is a mandatory section of the discipline and is aimed at the comprehensive formation of universal and general professional competencies of students. Modern requirements for specialists determine the particular importance of cultivating students' persistent cognitive interest, developing analytical and creative thinking, which are integral characteristics of a harmoniously and comprehensively developed personality. The purpose of SRW is to expand and deepen students' knowledge

in the field of theoretical foundations of the disciplines studied, to obtain and develop certain practical skills of independent research activities;

- develop the skills to competently present the results of one's own scientific research (reports, abstracts, papers, etc.) and the ability to reasonably defend and justify the results obtained;

## 4.2 Situational tasks, exercises

### Example No. 1.

How did Byzantine traditions influence the formation of the culture of Ancient Rus'?

#### **SOLUTION .**

The culture of Kievan Rus inherited the culture of the East Slavic tribes that formed the core of the state. It was undoubtedly influenced by the nomadic peoples of the Steppe and especially Byzantium, from which Christianity came to Rus.

In 988, under Vladimir I, Christianity was adopted as the state religion. Christianity, as the chronicler narrates, had been widespread in Russia since ancient times. At the beginning of our era, Apostle Andrew the First-Called, the elder brother of Apostle Peter, went to Scythia. As the Tale of Bygone Years testifies, Apostle Andrew ascended to the middle reaches of the Dnieper, erected a cross on the Kiev hills and predicted that Kiev would be the "mother of Russian cities". The chronicler's further journey lay through Novgorod, where, according to the chronicler, he was amazed by the Russian bathhouse, to the Baltic and further around Europe to Rome. Stories about subsequent baptisms of individual groups of the population of Russia show that Christianity gradually entered the life of the ancient Russian people.

The adoption of Christianity was of great importance for the further development of Russia. Christianity, with its idea of the eternity of human life, affirmed the idea of the equality of people before God. According to the new religion, the path to paradise was open to both a rich nobleman and a commoner, depending on their honest fulfillment of their duties on earth.

The adoption of Christianity played a major role in the development of Russian culture, which experienced the influence of Byzantine, and through it, ancient culture.

The adoption of Christianity in the Orthodox tradition became one of the determining factors of our further historical development. Vladimir was canonized by the church as a saint and for his services in the baptism of Rus' is called equal to the apostles.

Byzantine masters built the first stone churches in Rus', the interiors of which were decorated with mosaics and fresco paintings; the first examples of painting art - icons and miniature manuscripts - were brought from Constantinople to Kyiv and other cities.

Christianity in Russia is a little over a thousand years old, and the art of icon painting has equally ancient roots. The icon (from the Greek word meaning "image", "picture") arose before the birth of ancient Russian culture, and became widespread in all Orthodox countries. Icons in Russia appeared as a result of the missionary activity of the Byzantine Church during the period when the importance of church art was experienced with particular force. During this period, church art was not as developed anywhere in Europe as in Byzantium. And at this time, the newly converted Russia received, among other icons, as an example of Orthodox art, an unsurpassed masterpiece - the icon of the Mother of God, which later received the name of Vladimir.

Rus' had a highly developed artistic culture. All this contributed to the fact that the collaboration of Russian and Byzantine masters was exceptionally fruitful.

The newly converted people proved capable of accepting the Byzantine heritage, which had nowhere found such favorable soil and had nowhere produced such results as in Rus'.

Rus' accepted baptism from Byzantium and with it inherited the idea that the task of painting is to "embody the word", to embody the Christian doctrine in images. Therefore, the great Christian "word" lies at the basis of ancient Russian painting. First of all, this is the Holy Scripture, the Bible ("Bible" in Greek means books) - books created, according to the Christian doctrine, by the inspiration of the Holy Spirit.

Soon after the completion of the main church of Rus', the Kievan Sophia (whose dedication repeated the name of the main church of the capital of Byzantium, Constantinople), the "Word on Law and Grace" by Metropolitan Hilarion was written, which aimed to establish the foundations of the new Christian worldview. Thus, at the end of the 10th century, the lands of Kievan Rus' entered the Christian world, falling under the influence of Byzantium.

The five-domed church in honor of the icon "Joy of All Who Sorrow" was founded in 1904 and consecrated in 1907. It was a house church at the diocesan girls' school. After the October Revolution, the building of the diocesan girls' school housed a naval base, then the department of public education and pedagogical courses. Now (2018) it is the main building of Pedagogical School No. 1, and the premises of the house church housed an assembly hall for almost 90 years. In 2011, the church in honor of the icon "Joy of All Who Sorrow" became an active Orthodox church. The church bell tower was restored. November 4, 2013 Bishop of Blagoveshchensk and Tynda Lucian consecrated the revived church
